AGREEMENT TO TERMS AND CONDITIONS

In consideration of the granting and extension of credit by TKO Electronics, Inc. (hereinafter called "Seller") the undersigned (also called the Buyer), it is hereby agreed that the undersigned will promptly pay all sums for good shipped against order when in the event of nonpayment, the undersigned does hereby agree to pay in addition to the principal amounts due, all collection charges incurred by the Seller, including charges made by a collection agent and in the event of suit, reasonable attorney's fees and court costs. The undersigned further agrees to pay late payment penalty for invoices not paid according to terms, at the rate specified on Seller's price list in effect on date of order, commencing the first day following the due date. Upon Applicant's failure to pay any indebtedness owed to Seller when due, or when any statement of information submitted by Applicant to Seller is false when made, Seller may, at its option, declare all indebtedness immediately due and payable, and interest shall accrue on such indebtedness at the rate of 18 percent annum or the maximum rate permitted by law, whichever is less. Checks returned due to insufficient funds subject undersigned to a NSF Fee of \$35. All returns must have an authorized RMA#, and return freight is F.O.B. origin. Returns are subject to a 15% restocking fee, (excludes defective). Net 30 is defined as payment received within 30 days. Undersigned has 10 days to dispute an invoice. Acceptance and delivery of all purchase orders is expressly conditioned upon the Seller. **Payments made by credit card are subject to a 3.5% handling fee.
